CAM Arbitration Rules

As per Art. 10 of the [Arbitration Rules](#) (in force as from 1 March 2023), please find enclosed
the request for arbitration and the enclosures attached thereto.

Reply to the Request for arbitration

According to Art. 11 of the Rules, Respondent shall file its Reply within thirty (30) days
from the receipt of the Request served by certified mail. Please note that if Respondent
does not file any reply, the arbitration will continue *in absentia* and the final award will
maintain all its legal effects (Art. 11.4 of the Rules).

Submission for Respondent's reply to the Request for arbitration

Respondent is reminded of its duty under Italian fiscal law – where applicable – to place
revenue stamps ("*marche da bollo*", each of Euro 16) every four pages on both the
submission and the power of attorney. The number of stamps shall be one for each
respondent, plus one for the Chamber (e.g. if there is one respondent, two revenue
stamps shall be placed every four pages, if there are two respondents, three revenue
stamps shall be placed, and so on). If conferred, the power of attorney for the defense
counsel must also bear one revenue stamp of the same kind.

In case Respondent's reply is **signed digitally (Pades)**, it shall be filed via certified mail (PEC) at arbitrato.notify@legalmail.it already bearing any due fiscal stamps, together with any annexed documents; the latter can be submitted via Wetransfer or similar providers.

In case Respondent's reply is **not signed digitally**, it shall be filed via e-mail at segreteria.arbitrato@mi.camcom.it or certified mail (PEC) at arbitrato.notify@legalmail.it already bearing any due fiscal stamps where applicable, together with any annexed documents; the latter can be submitted via Wetransfer or similar providers. Furthermore, Respondent shall submit, by courier or mail, one original hard copy of its Reply within the following 5 working days at the Chamber of Arbitration; any enclosed documents shall be submitted in .pdf format on USB device, hard disk or CD-Rom.
